ORDER


And Whereas the Banipur Govt. Primary Teachers Training Institute cum DIET, Unit-II, P.O - Banipur, Dist- North 24 Parganas, West Bengal - 743233 was granted recognition vide order No.ERC/7-14/2000/1565 dated 19.07.2000 for PTT course from the academic session 2000-2001 with an intake of 50 students for one year course under 14(3) (a) of NCTE Act.1993 with condition that institution will continue to fulfill norms laid down by NCTE time to time.

And Whereas the NCTE Act, Rules and Regulations notified from time to time clearly stated that the Elementary Teacher Education Programme should be of 2 years duration. However, a relaxation in Appendix - V of the Rule given to the states to run 1 year Elementary course till 2004-2005 after which the institution were to switch over to 2 years courses.

And Whereas the matter was discussed in the ERC meeting time to time and notices were issued to the institutions instructing them not to admit students till the compliance of the requirement as per NCTE Regulations.

And Whereas the Eastern Regional Committee in its 95th meeting held on 27th - 29th April, 2009 considered the matter relating to Elementary institutions in the state of West Bengal with reference to switching PTT/ETE/D.Ed. course to 2 years duration as per the NCTE regulation. The Committee noted the letter dated 16.04.2009 of West Bengal Board of Primary Education and the Notification No. 1039-SE (Pry) dated 23rd October 2008 to the effect that the Government of West Bengal has switched over to the two year D.Ed. course in place of one year Primary Teacher Training (PTT) course and accordingly appointed the West Bengal Board of Primary Education as the affiliating/ examining body.

Now therefore in exercise of the authority vested and as per the decision of the Eastern Regional Committee the Banipur Govt. Primary Teachers Training Institute, Unit-II, P.O - Banipur, Dist- North 24 Parganas, West Bengal - 743233 is hereby permitted to admit students and run PTT/ETE/D.Ed. course of 2 years duration from the session 2009-2010 as per the terms and conditions mentioned in the recognition order/ orders issued as per the NCTE Act., Rules and Regulations.

ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, **Banipur Govt. PTI Cum DIET Unit II, Plot No. 2268, 2267, 2266, 2265, 2277, 2300, Street No. K.N.Roy RD, Vill/Po.- Banipur, Tehsil/Taluka- Touzi 2167, Town/City - Habra, Dist.- North 24 Parganas, West Bengal – 743233** has applied for grant of permission for **Addl. Intake of D.El.Ed. course online on 30/07/2013** for 2 year duration Under Section 15(1) of the NCTE Act, 1993 and hard copy received by Eastern Regional Committee of on 12.08.2013.

2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and Videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE ACT, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants permission to Banipur Govt. PTI Cum DIET Unit II, Plot No. 2268, 2267, 2266, 2265, 2277, 2300, Street No. K.N.Roy RD, Vill/Po.- Banipur, Tehsil/Taluka- Touzi 2167, Town/City - Habra, Dist.- North 24 Parganas, West Bengal – 743233 for conducting **D.El.Ed. programme of two year duration with an additional intake of 50 students (additional one unit), (existing 50 intake + additional 50 intake), thus making the total intake of 100 (one hundred)** from the academic session **2016-2017** under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- (i) The Endowment fund of 5 lakhs and Reserve fund of 7 lakhs kept in joint account with Regional Director of NCTE should be maintained Perpetually. Loan raising against or mortgaging of FDR's shall not be done.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- (iii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Regulation Norms & Procedure) Regulations 2014.
 - (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in Position.
2. Further the recognition is subject to the condition that the institution shall move gradually to become a composite institution but not later than 2016-17.
3. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
4. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
5. The institution shall maintain its website with hyperlink to the Council and the Southern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
- a) Sanctioned programmes along with annual intake in the institution:
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter:
 - d) Names of Students admitted during the current session along with qualification,
Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information, if it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

6. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
7. The institution shall make available list of students admitted on its official website.
8. If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued thereunder, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
